The Foundation is an autonomous non-profit 501(c) (3) corporation created to serve the South Brunswick School District by enhancing public school education through private funding.

The Foundation looks to foster educational opportunities, creativity, and achievement in the South Brunswick Public Schools by providing funding for grants of student programs, innovative professional development opportunities for staff and student scholarships by generating corporate and private financial support, and encouraging volunteer time.
